- **General protective and hygienic measures:**  
Keep away from foodstuffs, beverages and feed.  
Wash hands before breaks and at the end of work.
- **Breathing equipment:**  
In case of brief exposure or low pollution use respiratory filter device. In case of intensive or longer exposure use respiratory protective device that is independent of circulating air.
- **Protection of hands:**  
The glove material has to be impermeable and resistant to the product/ the substance/ the preparation.
